Fall in Rice production during 1978

2667. SHRIMATI KRISHNA SAHI: Will the Minister of AGRICULTURE be pleased to state:

(a) whether rice production went down by 11.7 million tonnes from 80.7 nillion tonnes in 1978 to 69 million tonnes in 1979; and

(b) if so, the reasons for this fall in production?

THE MINISTER OF AGRICUL-TURE AND RURAL RECONSTRUC-TION (SHRI BIRENDRA SINGH RAO): (a) and (b). Final estimates of rice production for the year .979-80 have not yet become available from all the State Governments. However, according to current assessment, the production of rice during 1979-80 is likely to register a sharp decline compared to the level of 53.83 million tonnes in 1978-79 due largely to a severe drought in many parts of the country.
