THE MINISTER OF STATE IN MINISTRY OF DEFENCE THE (SHRI C. P. N. SINGH): (a) to (c) There is no specific proposal for setting up a new unit of M|s Bharat Electronics Ltd. (BEL) in West Bengal. However, BEL has submitted a proposal for augmentation of their equipment production capacity. to meet the additional requirements of Defence Services by setting up two new units Several State Governments including West Bengal. have requested that one of the units may be set up in their respective States. The question of location of the units will be considered at the time of taking a final decision on BEL's proposal taking into account all relevant factors.
