

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH (SHRI NIHAR RANJAN LASKAR): (a) For the first India Population Project, financial assistance of S 21.2 million was received from the World Bank.

For the Second India Population Project, the World Bank is expected to provide assistance to the tune of \$46 million.

No technical Assistance has been received from the World Bank for either of these Projects as none has been sought or is required.

(b) The physical, financial and programme results as envisaged in the Project have largely been attained in respect of the First India, India Population Project. This project came to a class on 31-3-80.

The 2nd IPP has started during 1980-81.

(c) In the Second India Population Project 6 districts of Uttar Pradesh and 3 districts of Andhra Pradesh are being covered. The Project is designed to increase and strengthen, in about five years, facilities and manpower for delivery of Health and Family Welfare services, in an integrated manner in the selected districts, to reach a level that, over a longer period, will be ultimately reached in the entire country. The Project includes Information, Education and Communication activities, including Opinion Leaders camps and other mass media activities, management training for staff, Monitoring and Evaluation, some amount for innovative activities, etc.

Extension of train No. 95 Up upto Ahmedabad
