Restrictions on Indian Doctors in Iran

6383. SHRIMATI KISHORI SINHA: Will the Minister of EXTERNAL AF-FAIRS be pleased to state:

- (a) whether Indian doctors working in Iran had complained of imposition by the Iran Government of restrictions which were not mentioned in the contract;
- (b) whether specialists are being forced to work as generalists and at a lower pay than was promised in the contract; and
- (c) whether Government had taken this up with the Government of Iran?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO): (a) to (c). While no complaints of imposition of any restrictions which were not mentioned in the contract or of specialists being forced to work as general-duty doctors have been received by us, there have, however, been some localised problems. There have been occasions when specialists have been requested to attend to work normally to be handled by general-duty doctors because of shortage of doctors and also because of confidence in our doctors. Whenever such problems have been brought to the notice of our Embassy, these have been taken up with the Iranian authorities and all efforts made to get them resolved.
