THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI KHURSHED ALAM KHAN): (a) to (d). No such improvement fund has been created. Tea Board, however, has formulated a 10 Year Development Programme for Extension, Planting, Replanting and Rejuvination of tea bushes and modernisation of factories which is expected to significantly increase the production, productivity and economic viability of the Darjeeling tea gardens. It is expected that with the over-all improvement in the economic condition of the Darjeeling gardens, the level of wages and other amenities for labourers would also improve.

### Proposal for setting up a Fashion Technology Institute in Tamil Nadu

3584. SHRI K T. KOSALRAM: Will the Minister of COMMERCE be pleased to state the details of the proposal of setting up a Fashion Technology Institute involving possibly foreign collaboration, in Tamil Nadu for promoting production of quality cloth in the handloom sector both for domestic needs and export markets?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI KHURSHED ALAM KHAN): Government is not aware of any proposal for setting up a Fashion Technology Institute involving foreign collaboration in Tamil Nadu.

However, proposals have been received from the Clothing Manufacturers Association of India, Bombay to establish a Fashion Forecast Clubcum-Library and also from the Apparels Export Promotion Council for setting up of a Fashion Design Institute. These are under consideration of Government.

# कपड़ा मिलों द्वारा धोखा दिया जाना

3586 श्री फूलचन्द दर्माः क्या वाणिज्य मंत्री यह बताने की कुपा करणे किः

(क) क्या भारत सरकार के कपड़ा आयुक्त ने अगस्त 1980 में इन्दोर में कपड़ा निर्मा-ताओं के एक समारोह में दिए गए अपने भाषण में यह कहा था कि दोश में बहुत सी कपड़ा मिलें सस्ती किस्म के माल से बने कपड़ों पर 'उच्च किस्म के नकली धागे से बना कपड़ा' मोहर लगा कर जनता को धोखा दे रही ह<sup>4</sup>;

(स) यदि हां, तो सरकार ने इस बारे में क्या कार्यवाही की है तथा उन मिलों तथा मिलमालिकों के नाम क्या है जिनके विरुद्ध कार्यवाही की गई और क्या हुक्म चन्द मिल्स, इन्दार तथा जियाजी मिल, ग्वालियर भी उन मिलों में है; और

(ग) पदि हां, तो पूरे ब्यारे क्या है तथा सरकार द्वारा इस बारे में क्या कदम उठाये जाने है।

वाणिष्य तथा इत्यात व खान मंत्री (भी प्रणव मुखर्जी): (क). वस्त्र आयुकत द्वारा यह कहा गया बगाया जाता है कि उप-भोक्ताओं के हितां का संरक्षण करने के लिए रेशा मिश्रण के समुचित चिन्हों कन की जरूरत है। उन्होंने उल्लेख किया कि अनु-चित चिन्हों कन के उदाहरण सामने आये हैं।

(ख) तथा (ग). अपर वस्त्र आयुक्त की अध्यक्षता में अधिकारियों की एक समिति कथित अनुचित चिन्हांकन के सामलों की जांच करती रही है । यर्ष 1979 तथा 1980 में इस समिति द्वारा 27 मामलों पर विचार किया गया । साधारणतः, संहिलष्ट अंश का ठीक उल्लेख किया गुया जबकि सूती तथा सैलूलोसिक अंश के बीच कुछ मामूली भिन्नता रही। चुकि अकेले संश्लिष्ट अपेक्षाकृत उत्त्वी कीमत वाले अतः धोखा दोने का उद्दोश्य स्थापित नहीं किया जा सका । समिति के समक्षं मामलों की सूची में जियाजी मिल्स, ग्वालियर का नाम नहीं है; तथापि, हुकम चन्द मिल्स का नाम है परन्तु परीक्षण से पता चला कि विशिष्टियां मिल की घोषणा के अनुरूप हैं। वस्त्र आयुक्त का कार्यालय रोशा अंश की ठीक-ठीक घोषणा सुनिश्चित करने के लिए निगरानी रखता रहगा।

### Tungsten Lime Stone and Lead Deposits Fund in Sirohi District

3587. SHRI VIRDA RAM PHUL-WARIYA: Will the Minister of STEEL AND MINES be pleased to state:

(a) the estimated quantity of tungsten, lime stone and lead deposits fund in Sirohi District; and

(b) the revenue accrued to Government from these minerals?

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) As a result of work carried out by Geological Survey of India in Sirohi district of Rajasthan, Tungsten mineralisation has been recorded near Sirohi town for a strike length of 2.5 kms., having average width of 500 metres. A reserve of 2,300 tonnes of Wolframite has been estimated. The prospect is under investigation. Limestone deposits were located at a number of
