

सेवा के उपरान्त लिपिक संवर्ग में नियुक्ति पर विचार किया जाता है। वे कर्मचारी, जो मिडिल कक्षा पास हैं, 8 वर्ष की सेवा पूरी करने के पश्चात् उन्हें गोदाम-कीपर/रिकार्ड-कीपर/बिल-क्लेक्टर/खजांची (सभी लिपिक संवर्ग के पदों) के पदों पर पदोन्नति देने के लिए विचार किया जाता है। कर्मचारियों के काम के घंटों का ध्यान में रखते हुए 1/2 तथा 1/3 वेतन-मान पर नियुक्तियां की जाती हैं। जब भी ऐसी रिक्तियां होती हैं, उनकी पूर्ण-कालिक नियुक्तियों पर विचार किया जाता है और उन्हें ऐसे उम्मीदवारों की तुलना में तरजीह दी जाती है जो कि बैंक में कार्यरत नहीं होते। अधीनस्थ संवर्ग के कर्मचारियों की भर्ती बैंक द्वारा पूरी निष्पक्षता के साथ की जाती है।

जहां तक संघ द्वारा इश्तिहार में अनुसूचित जाति/अनुसूचित जनजाति के वास्ते आरक्षित रिक्तियों में से बाकी बचे रहे पदों पर पदोन्नति दिये जाने से सम्बन्धित आरोपों का सम्बन्ध है, यह मामला उपयुक्त कार्यवाही के लिए बैंक के साथ उठाया गया है।

#### **Foreign Exchange repatriated by US Corporation, CARE INC.**

Will the Minister of FINANCE be pleased to state:

(a) whether the U.S. Corporation, CARE Inc. has been annually repatriating foreign exchange in U.S. dollars to its Head Office America through the Reserve Bank of India;

(b) what is total and year-wise amount so repatriated in foreign exchange by CARE;

(c) whether the sources of the funds for the foreign exchange were from Indian Government or non-Government sources; and

(d) whether or not under the Laws of India CARE is required to prepare and/or maintain regular books of accounts and financial records in respect of its funding and operations in India?

THE MINISTER OF FINANCE (SHRI R. VENKATARAMAN): (a) Yes, Sir.

(b) The total and year-wise amount repatriated in foreign exchange by CARE is given in the statement attached.

(c) The sources of funds for which conversion in foreign exchange is allowed are from State governmental sources which receive food commodity assistance.

(d) There is no provision in the agreement signed between the Government of India and CARE for maintaining accounts. However, CARE maintains statements of accounts of its operations in India according to its regulations.

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI A. P. SHARMA): (a) The Air India Employees' Guild went on a strike demanding 20 per cent Bonus for the year 1979-80.
