3723. SHRI K. MALLANNA: Will the Minister of STEEL AND MINES be pleased to state:

- (a) whether Government's attention has been invited to the 'Hindustan Times' dated 11th August, 1980 according to which the biggest piece of diamond, the Vijay weighing 44.45 carats was found in 1961 in shallow mines and auctioned in 1964, fetched over Rs. 4.12 lakh and of this rupees 2.52 lakh went income-tax and  $\mathbf{a}_{\mathbf{S}}$ Rs. 83,000 as royalty and the finder got only Rs. 73,000 of which the salestax department wanted a share and litigation was going on;
- (b) whether it is a fact that about diamond mines operated by the National Minerals Development Corporation it is said that although a diamond weighing 44.45 carats was found in shallow mines no diamond weighing more than 22 carats was found in the primary mine of Majhagawan, the main source of diamonds:
- (c) whether Government have received reports that smugglers slip in and out of the 350 sq. mile Panna
