years or so as Consultants in different fields on payments of fabulous fees without obtaining approval of competent authority; if so, the details thereof;

- (b) whether it is also a fact that officers thus appointed did not obtain permission of competent authority for accepting such assignments;
- (c) whether it is also a fact that such officers have been extended travel facilities and paid for more than what is permissible to them under the Rules:
- (d) if so, what action is proposed to be taken against the officers who made wrong appointments, and allowed payments far in excess of the entitlements; and
- (e) whether it is also proposed to take action against the retired Government Officers who accepted these appointments at fees to which they were not entitled to?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI KHURSHEED ALAM KHAN): (a) to (c). No, Sir. There have been two cases of appointment of retired officers of the Board as Consultants and in both cases approval of competent authority was obtained.

(d) and (e). Do not arise.

Remands of Class I officers of L.I.C.

- (a) whether Class I Officers of the L.I.C. went on mass casual leave on 28th November, 1980.
- (b) if so, demands of class I Officers; and
- (c) Government's decision thereon and steps taken for implementation of earlier assurances; if any?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI MAGANBHAI BAROT): (a) to (c). The L.I.C. Management has reported that a large number of Class I Officers were on casual leave on 28-11-80. Their main demands are as under:—

- (i) Revision of pay scales etc. and
- (ii) Removal of anomalies between the emoluments of Officers and clerical staff.

In response to the demands of the Class I Officers, the management of the L.I.C. has offered concrete proposals which contain substantial improvements in their pay scales and other terms and conditions of service.
