orders have been passed on the case. The Superintendent involved in the case has retired from service on superannuation.

Dead Accounts with Nationalised Banks

- (a) what is the total number of dead accounts with all the nationalised banks upto November, 1980; and
- (b) what is the largest amount of money involved in a single dead account?

Raising the Scare of over-Production of Steel in Developing Countries

4604. SHRI SAMAR MUKHERJEE: Will the Minister of STEEL AND MINES be pleased to state:

- (a) whether Government are aware that the industrialised capitalist countries have raised, through their International Iron and Steel Institute, the scare of over-production of Steel in developing countries; and
- (b) if so, the reaction of Government thereto?

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) The Annual Report of the Secretary General to the 14th International Iron and Steel Institute Annual Conference, held in Madrid, Spain in October, 1980 contained a reference to the rising trend of steel production in the developing countries. No apprehension, as such, has been raised on over-production of steel in developing countries.

(b) Government propose to continue with the developmental activities for creation of additional steel making capacity taking demand into account.

Diversion of rivulet called Domhani Jore near Chasnalla Collieries
