**IA Direct Flight from New Delhi to  
Bhubaneswar ignoring West Bengal's  
Tourist Interest**

**4614. SHRI KRISHNA CHANDRA  
HALDER:** Will the Minister of  
**TOURISM AND CIVIL AVIATION** be  
pleased to state:

(a) the Indian Airlines has introduced three direct flights a week from New Delhi to Bhubaneswar ignoring West Bengal's tourist interest; and

(b) whether he is aware of the fact that 50 per cent of Orissa bound tourists usually pass through West Bengal?

**THE MINISTER OF TOURISM  
AND CIVIL AVIATION (SHRI A. P.  
SHARMA):** (a) and (b). Indian Airlines is presently operating a thrice weekly B-737 service on the Delhi-Khajuraho-Varanasi-Bhubaneswar route introduced in response to repeated demands for an airlink between Delhi and Bhubaneswar to cater to the growing traffic on this route.

The F-27 services between Calcutta and Bhubaneswar continue for meeting the demands of tourists between Bhubaneswar and Calcutta. Neither the services nor the passenger capacity offered between Calcutta and Bhubaneswar have been disturbed by Indian Airlines.

**Handloom Development Corporation**
