Provision of employment in all India Handicraft Board

4702. SHRIMATI SUSEELA GO-PALAN: Will the Minister of COM-MERCE be pleased to state:

- (a) the total number of employment provided in All India Handicrafts Board during the last three years; and
- (b) the steps Government have taken to provide employment opportunities to rural artisans?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI KHURSHEED ALAM KHAN):
(a) 1532.

(b) The Board has undertaken programmes for training of artisans in various craft such as Carpets. Art metalwares, hand-printed textiles and cane & bamboo crafts to increase their production base. These training programmes are likely to result in providing employment opportunities to rural artisans.

Recovery of loss in Eastern Units of National Textile Corporation

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) Some of the important steps taken to improve the working of these mills are as follows:—

- (i) modernisation, expansion, etc. of the mills;
- (ii) rationalisation of workload and labour force;

- (iii) bulk procurement of raw materials on centralised basis;
- (iv) diversification in the pattern of production; and
- (v) installation of diesel generating sets in some of the units to overcome power shortages.
- (b) The Auditors have not made any observations about the loss in their latest report dated 23rd June, 1980, in respect of the accounts of NTC (WBAB&O) Ltd. for the year 1978-79.
