(d) what steps Government propose to take to put the industry back on sound footing?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI KHURSHEED ALAM KHAN): (a) The number of traditional looms and the number of looms in the cooperative sector are 6 lakhs and 3.27 lakhs respectively.

- (b) Although working capital is around 30 per cent of the total requirements, it is not on account of any restriction imposed by the RBI. The weavers cooperative societies will get more loans subject to fulfilment of certain norms.
- (c) According to information received from Director of Handlooms & Textiles, Andhra Pradesh, no difficulty is experienced regarding supply of yarn. The prices of yarn have been ruling steady during the last 6 months. Only very recently, the prices have risen slightly on of account imposition of power cut in Tamil Nadu. The problem of accumulation of stocks is also not serious. Under the Government of India sponsored 20 per cent rebate scheme, considerable quantities have been sold during the Dussehra & Deepavali seasons. The apex society lifts 50 to 60 per cent of the production of primary societies on an average. However depending upon the seasonal fluctuations of demand the actual procurement also varies from month to month.
- (d) The stocks with the societies are expected to be cleared during the ensuing Sankranti festival which is the major buying season when 20 per cent rebate will also be allowed. The State Government have also arranged for sanction of additional credit limits of Rs. 2 crores to the

apex society to procure more stocks from primaries.
