- (a) whether it is a fact that the wholesale price index of the essential commodities has continued its rising trend:
- (b) if so, the group-wise details of the per cent increase in the price index at the end of each of the weeks since June this year; and
- (c) the facts causing such increase in the prices?

THE DEPUTY MINISTER IN THE MINISTRY OF CIVIL SUPPLIES (SHRI BRAJAMOHAN MOHANTY): (a) During the past five months there has been a mixesd trend in the whole-sale price indices of essential commodities in as much as indices of some essential commodities have gone up, some have remained steady and that of some have declined.

- (b) The weekly percentage variation in the wholesale price indices of 11 groups of commodities is given in the statement laid on the Table of the House. [Placed in Library. See No. LT-1378/80).
- (c) Apart from the general inflationary situation the rise in prices of some essential commodities, widesprattributed to decline in production of some essential commodities, widespread drought in 1979, increase in the prices of petro-products, increase in support/support/procurement prices, shortfall in power supply, transport bottleneck and the seasonality factor.
