(b) whether it is also a fact that the amount of foreign exchange involved is more than Rs. 5 crores; and

(c) if so, the details thereof?

THE MINISTER OF STATE IN THE FINANCE (SHRI MINISTRY OF SAWAI SINGH SISODIA): (a) to (c). As per information available with the Oriental Bank of Government, the Commerce has not concluded any sales involving purchases contract foreign exchange on behalf of Thapers. The C.B.I. however is investigating a case involving foreign exchange transactions relating to this bank. It will not be in public interest to divulge further details at this stage.

Heavy Expenditure on Air India Employees posted Abroad

d49. SHRIMATI KRISHNA SAHI: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

- (a) whether it is a fact that Air India spent half of its wage bill .i.e. Rs. 23 crores in 1979-80 for keeping 2190 employees abroad as against Rs. 27 crores for keeping 13160 employees at home; and
- (b) if so, what is the justification of keeping huge contingent of 2190 employees abroad?

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI A. P. SHAR-MA): (a) During the year 1979-80, the wage bill for 2,190 employees rosted abroad and 13,160 employees in India amounted to Rs. 23.89 crores and Rs. 26.94 crores respectively.

(b) Air India has 40 on-line and 61 off-line offices abroad. Out of 2,190 staff abroad 1,538 work in traffic and sales departments. The Corporation earns 75 per cent of its traffic revenue abroad and the average salary in terms of employees at foreign station works out approximately five times the salary of the staff employed in India. However, in view of high per

employee cost abroad, all efforts are made by Air India to resort to mechanisation wherever, possible and reduce staff. The present staff strength is after detailed scrutiny of man-power requirements of each station though efforts are constantly made to reduce such staff wherever found possible without affecting efficiency.
