### Progress of Visakhapatnam Steel Plant

654. SHRI KUSUMA KRISHNA MURTHY: Will the Minister of STEE! AND MINES be pleased to state:

- (a) the present stage of progress of Visakhapatnam Steel Plant; and
- (b) response of the Planning Commission towards this steel plant during the current financial year?

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHR) PRANAB MUKHERJEE): (a) Various preliminary infrastructural and preconstruction activities in respect of Visakhapatnam Steel Plant have been in progresss at site. Of the total estimated requirement of 26600 acres of land for plant, township and off-site facilities, 14308.39 acres had already been acquired till end of September, 1980. Site-levelling works are in progress and around 2 million cubic metres of earth work had been completed till 31-10-1980. Works are also in progress in respect of approach road construction of water and power distribution, site offices, storage construction of laboratory etc. The State Government is taking action for rehabilitation of displaced families, Railways have also taken up work on construction siding for the Steel Plant. Till 30-9-1980 the cumuexpenditure on the project amounted to Rs. 35.55 crores.

for the plant prepared earlier is being revised. The Soviet portion of the revised DPR has already been received and the comprehensive revised DPR is expected to be received by the end of November, 1980.

(b) The Annual Plan for 1980-81 contains a provision of Rs. 70.00 crores for Visakhapatnam Steel Plant.

# Applicability of Industrial Dispute Act. 1947 to GIC

655. SHRI SUNIL MAITRA: Will the Minister of FINANCE be pleased to state:

- (a) whether the Finance Ministry insists that Industrial Dispute Act, 1947 is not applicable to the General Insurance Corporation; and
  - (b) if so, reasons thereof?

THE DEPUTY MINISTER IN THE MINISTRY  $\mathbf{OF}$ FINANCE MAGANBHAI BAROT): (a) and (b). The scales of pay and other conditions service of the employees of the General Insurance are governed by Statutory Schemes framed from time to time by Central Government in exercise of the powers conferred under section 16 of the General Insurance Business (Nationalisation) Act, 1972. In view of this the question of applicability of the Industrial Dispute Act to the General Insurance Inqustry in so far as the matters covered by the Statutory Schemes are concerned, does not arise.

वित्त मंत्रालय में राज्य मंत्री (श्री सवाई सिंह सिसोदिया) : (क) तीसरे वेतन को साथ मंहगाई भत्ते के विलय के संबंध में कोई विशेष सिफारिश नहीं की थी । उसने केवल इतनी ही सिफारिश की थी कि क्या मंहगाई भत्ते के एक भाग की विशिष्ट प्रयोजनों के लिए बेतन के रूप में भाना जाना चाहिए, इस प्रकार सरकार द्वारा विभिन्न विचारों को ध्यान में रखते हुए निर्णय किया जाता रहना चाहिए।

(ख) 30-9-77 से, श्रखिल भारतीय श्रमिक वर्ग उपभोक्ता मूल्य संचकांक के श्रौसत सूचकांक स्तर 272 तक जो मंह-गई भत्ता स्बीकृत किया गया है, उसे पेंशन संबंधी लाभों के प्रयोजन के लिए वेतन के साथ विलय माना गया है। राष्ट्रीय परिषद (संयुक्त परामर्गदाता तंत्र, के कर्मचारी पक्ष ने 12 मास के श्रौसत सूचकांक स्तर 344 तक स्वीकृत मंहगाई भत्ते को सभी प्रयोजनों के लिए वेतन के साथ विलय करने की मांग की है। इस मांग को राष्ट्रीय परिषद की एक समिति को भंज दिया गया है।
