(b), (d), (e) and (f). The monthly rate of inflation has come down in the current financial year from 4.1 per cent in July to 1 per cent in August, 1.7 per cent in September and 0.6 per cent in October 1980. In the two successive weeks ended 25-10-1980 and 1-11-1980 the Wholesale price Index has fallen sharply by 1.2 per cent and 1.7 per cent respectively. This has mainly been due to various anti-inflationary measures taken by the present Government.

The continuation of inflationary upsurge 1979-80 and seasonal pressures accentuated by severe drought conditions were responsible for the continued rise in prices. International price situation and continued increase in the prices of petroleum products were also responsible. Equally important were the cost-push increase due to the upward adjustment in administered prices and the excess liquidity in the system. Smuggling and hoardin of certain sensitive commodities by anti-social elements also aggravated the price situation.

The focus of anti-inflationary policy is on increasing supplies through higher production, better capacity utilization and efficient functioning of infrastructure sectors. Public distribution system is being revamped and made a permanent feature of the economy. At the same time efforts have been made to restrict the expansion of money supply and bank credit. It is hoped that with the help of these measures prices will be brought under reasonable control.
