Raids by Income-tax Department

JYOTIRMOY BOSU: 740. SHRI Will the Minister of FINANCE be pleased to state:

- (a) how many raids were conducted by the income-tax Department in search for tax evaded income and wealth during the past three months;
- (b) names, addresses, designations and particulars of persons whose residences or business premises were raided during this period;
- (c) total amount of unaccounted money in cash and kind detected in each case; and

THE MINISTER OF STATE MINISTRY THE OF FINANCE S. S. (SHRI SISODIA): (a) Sir, during the last three months, i.e. August, 1980 to October 1980, the Income-Tax Department has conducted 1321 searches for unearthing concealed income and wealth. In these searches cash, bullion, jewellery and other valuables worth rupees 4.54 crores approximately have been seiz-

(b) and (c). Considerable and effort will be involved in giving

details of name, address and seizure made in the case of each search. However, if the Hon'ble Member desires to have information about particular search, the same will be furnished.

(d) Detailed investigation in these cases is in progress and action will be taken against the defaulters evaders according to Law.

Stabilisation of wholesale prices

(b) and (c). The rate of inflation as measured by the Wholesale Price Index in the recent 3 months, August-October 1980 has come down to 1.1 per cent from 3.2 per cent in the preceding 3 months. The General Index of Wholesale Prices has fallen by 1.2 and 1.7 per cent during the two weeks ended 25,10.1980 and 1-11-1980-the latest available.

The modernisation in inflationary pressures is the result of the abatement of seasonal factors and antiinflationary measures already by the Government. The outlook of agricultural production is good and industrial output has started pulling up. While it is not possible to insulate the economy from imported inflation and the continued rise in the prices of oil and oil products, falling trend in prices augurs and price situation is expected to show a reasonable degree of stability in the coming months.

Setting up of pelletisation plant at Kudremukh
