THE MINISTER OF STATE (N FINANCE THE MINISTRY OF

(SHRI SAWAISINGH SISODIA): (a) The present rates of pension which came into force on 31st March, 1979 are as under. These rates are applicable to a qualifying service of 33 years. If the qualifying service is less than 33 years the pension is reduced proporationately.

(b) and (c) The ceiling on the maximum service qualifying for pension has always been a basic part of the pension formula to which maximum pension is linked. The service rendered beyond this period is taken into account for working pension. Before 1-1-1973 the maximum service qualifying for pension was restricted to 30 years. On recommendation of the Third Commission this was raised to 33 years with effect from 1-1-1973

Separate Domestic Terminal at Meenambakkam Airport

6304. SHRI K RAMAMURTHY: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

- (a) whether there is any proposal to have a separate domestic terminal in Meenambakkam Airport;
- (b) if so, the details of this scheme and when it will be commissioned:
- (c) the reason for the dropping of developing Madurai Airport runway for servicing Boeing Aircraft; and
- (d) by what time the airport Vagaikulam near Tuticorin would be commissioned?

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI A. P. SHARMA); (a) and (b). Construction of a new Domestic Terminal Complex at Madras airport at an estimated cost of Rs. 10.04 crores been approved by the Government. This project is likely to be completed by 1983-84. Scope of the project includes:

- (i) Construction of domestic terminal building with a peak hour handling capacity of 1207 arriving and departing passengers;
- (ii) Construction of associated apron area, apron lights and refuelling system;
- (iii) Construction of taxi-links, ground support equipment, parking area; and
- (iv) Construction of approach roads and car park area for the new terminal.
- (c) The proposal for strengthening Madurai airport runway for Boeing 737 aircraft has been deferred due to paucity of funds.
- (d) There are no plans at present to construct an airport in Vagaikulam near Tuticorin.
