Production of Alcohol

6644. SHRI R. K. MHALGI: Will the Minister of PETROLEUM, CHEMICALS AND FERTILIZERS be pleased to state:

(a) whether it is a fact that the country is not producing enough alcohal required for Industrial use;

(b) if so, what steps Government have taken to utilise the sugar rich molasses produced by gur and Khandsari industry for producing the required alcohol;

(c) figures for such use during the last three years;

(d) whether Government are aware of the reports published in certain journal (Business India, November 10-23) about large scale smuggling out of molasses and alcohol also; and

(e) if so, details thereof?

THE MINISTIG OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI P. C. SETHI): (a) The Central Molasses Board has estimated that in the current alcohol year 1980-81 (December-November), the availability of alcohol is likely to be 4200 lakhs litres as against an estimated aggregate demand of 5716.79 lakh litres.

(b) Molasses is not a by-product in the production of gur. All the State Governments have been requested to augment the availability of alcohol by promoting the use of khandsari molasses for alcohol production. (c) No figures for the use of khandsari molasses for alcohol production are available.

(d) and (e). The report referred to does not allege that there has been large scale smuggling of molasses and alcohol. It only states that prices of molasses and alcohol in India are much lower than the international prices and that this disparity in prices has provided a strong temptation to ship out molasses and alcohol. It also states that alcohol is being exported as crude rum. The export of molasses is canalised through the State Trading Corporation. In the molasses years 1979-80 and 1980-81, no molasses was released to STC for export. Following reports of export of alcohol as crude rum, the export of potable liquor and Indian made foreign liquor containing alcohol exceeding 50 per cent (P/Y) was banned with effect from 22nd September, 1980.
