Setting up of Centrally Sponsored Industrial Units in Rajasthan

6867. SHRI SATISH AGARWAL: SHRI NAWAL KISHORE SHARMA:

ACHARYA BHAGWAN DEV:

Will the Minister of INDUSTRY be pleased to state:

- (a) whether the Ministry have formulated schemes for setting Centrally sponsored industrial units in the States during the Sixth Plan period:
- (b) if so, the industrial units those are proposed to be set up in Rajasthan;
- (c) whether the State Government have forwarded to the Centre proposal for setting up industries with Central assistance and if so, the names and locations where such industrial units will be set up; and
- (d) the Central assistance that will be made available to the State?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI CHARANJIT CHANANA): (a) to (d). Normally all the State Governments approach Government of India for location of Central Public Sector Projects in the respective States. But the locations of Central Public Sector Projects are based on techno-economic considerations. However, under Central Plans, depending upon the resources available, Public industries are established in different States including Rajasthan various Central Projects in Rajasthan as included in the Sixth Five Year Plan (1980—85) are listed below:—

- 1. Hindustan Copper Ltd.; Khetri Copper Project (Khetri Copper Complex, Expansion of Smelter and refinery, bye-product plant Out-lay—Rs. 34.46 crores).
- 2. Hindustan Zinc Ltd.: Rajpura Dariba Mines, Zawarmala Maton Phosphate mines, exploration.

Bebari Smelter Expansion, Leach Residue Treatment Plant. Aguch-Baroi mines and smelter complex, Silver mercury recovery plants, Outpyrites utilisation plant etc. lav-Rs. 99.22 crores).

- 3. HMT Ltd.: Machine Tools Division, Ajmer-expansion, diversification etc. (Out-lay-Rs. 1.32 crores).
- 4. Heavy Water Project, Kota: Outlay—13.86 crores).
- 5. Pyrites & Phosphates Ltd.: Mining and beneficiation of pyrites at Saladipura, (Outlay-Rs. 10.50 crores).
- 6 Hindustan Salts Ltd.: Sambhar Salt (Outlay-Rs. 2 crores).
- 7. Instrumentation Ltd. Kota: Diversification expansion including manufacture of Milk analysers project which will be partly financed by the Rajasthan State Industrial Development and Investment Corporation. (Outlay-Rs. 3.85 crores)
- Indian Drugs & Pharmaceuticals. Ltd.: Joint Sector formulation unit (Outlay -Rs. 0.11 crores).

Setting up of Paper Mill in Tripura

- (a) whether any proposal for setting up of paper mill in Tripura is under consideration of Government;
- (b) if so, the present position thereof; and
- (c) what are the measures taken by Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI CHARANJIT CHANANA): (a) to (c). The Government of Tripura have proposed the setting up of a paper-pulp mill based on the bamboo resources of the State. It is, however, neces-
