

छठी योजना में हिमाचल प्रदेश का

आवंटन

6942. श्री कृष्ण दत्त सुलतानपुरी : क्या योजना मंत्री यह बताने की कृपा करेंगे कि :

(क) छठी योजना में हिमाचल प्रदेश के लिए कितनी धनराशि आवंटित की गई है और केन्द्र सरकार द्वारा वित्त पोषित किए जाने के लिए कितनी योजनाएँ मंजूर की गई हैं; और

(ख) राज्य सरकार ने कितनी राशि की मांग की थी और किन योजनाओं को प्राथमिकता दी गई है तथा तत्सम्बन्धी व्यय क्या है ?

योजना और भ्रम मंत्री (श्री नाथन दत्त तिवारी) : (क) और (ख). हिमाचल प्रदेश की छठी पंचवर्षीय योजना से संबंधित राज्य सरकार के कुल 701 करोड़ रु० के प्रस्तावों के मुकाबले राज्य सरकार के परामर्श में राज्य की छठी पंचवर्षीय योजना की 560 करोड़ रु० की राशि पर अंतिम रूप दिया गया। योजना आयोग आवंटन स्कीमवार नहीं करता। स्कीमवार आवंटन राज्य सरकारों द्वारा किए जाते हैं।

Aid for Anti-Dacoits Drive in Chambal

6943. SHRI MADHAVRAO SCINDIA: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether Madhya Pradesh and U.P. Police have sought the aid of Army and Air Force including the supports of helicopters in their anti-dacoits drive in Chambal and Jamuna ravines;

(b) if so, the details of the aid sought and received by police; and

(c) the success achieved in this regard so far?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI YOGENDRA MAKWANA): (a) to (c). Requests have been received from the Governments of Madhya Pradesh and Uttar Pradesh for assistance from the Defence Ministry for certain vehicles, weapons and equipment. It would not be in public interest to disclose their details. Government of India would take appropriate action in consultation with the two State Governments.

H.M.T. Watches

6944. SHRI R. K. MHALGI: Will the Minister of INDUSTRY be pleased to state:

(a) the number of mechanical and electronic watches produced and the installed capacity of HMT for the last two years, year-wise;

(b) what is the import component in both the categories;

(c) whether any watches are fully produced indigenously;

(d) the figures of sale of watches fully produced by H.M.T. and watches imported by H.M.T.;

(e) the names of the countries from which these are imported; and

(f) the figures for imported watches and indigenous watches manufactured at H.M.T.?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI CHARANJIT CHANANA): (a) The manufacture of electronic watches has not yet been undertaken by HMT Ltd. Installed capacity for manufacture of mechanical watches at HMT's own factories at Bangalore, Srinagar and Tumkur was 12 lakhs Nos. in 1979-80 and 23 lakhs Nos. in 1980-81. The total production of HMT watches (mechanical) during the last two years has been as under:—
