chairmanship of Dr. D. S. Kothari.
The recommendations of the Committee are under consideration of the Government.

SWAMINATHAN): (a) The Indian Dairy Corporation is setting up a plant at Itola near Baroda (Gujarat) for the production of laminated paper to be used for packing and marketing of aseptic milk in various urban areas.

(b) and (c). The proposal for production of laminated paper was revived and approved after a detailed consideration of all the aspects like acceptability of sterilised milk, its shelf life, and the importance of direct marketing of rurally produced milk in urban areas.
