THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIA-MENTARY AFFAIRS (SHRI MAL-LIKARJUN): (a) to (c) The feasibility of introducing an express train between Rayagada and Rourkela has been examined, but not found operationally feasible due to line capacity constraints on the single line section between Rayagada and Jharsuguda as well as on Jharsuguda-Rourkela section both of which are working to Apart 'from this, requisaturation. site resources like maintenance facilities at Rayagada, coaching stock and power, etc. are also not available for introducing the train at present.
