Manufacture of Railway Wagons

7068. SHRI DIGVIJAY SINH: Will Minister of RAILWAYS be pleased to state.

- (a) how many railway wagons have been manufactured annually in the last five years; and
- (b) what capacity is required with expected annual escalation of production?

THE DEPUTY MINISTER IN MINISTRY OF RAILWAYS THE AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) The number of wagons manufactured annually in the last 5 years is shown below:-

(b) The current 6th Five Year Plan provides for acquisition of 1.00,000 wagons in terms of 4-wheelers during the years 1980-85. The procurement on a year to year basis is however planned on the basis of funds allocated for the annual plans. During the years 1980-81 and 1981-82, 30,000 wagons in terms of 4wheelers are expected to be acquired. The procurement of 70,000 wagons in terms of 4-wheelers, the balance quantity, would be arranged during the remaining 3 years of the 6th Five Year Plan, namely from 1982-83 to 1985-86, and would be subject to allocation of adequate funds. This would necessitate stepping up wagon production to the level of 22.000/ 23,000 wagons in terms of fourwheelers per annum. The annual installed capacity for manufacture of railway wagons in the country is about 28,000 wagons in terms of fourwheelers

.Transportation of Milk and Pan

G. T. Express, 17 Dn. Janata Express and few other trains, and no difficulty is being experienced in the clearance of this traffic.

- (c) whether the victims include the children who had already been immunised against this disease;
- (d) if so, whether any enquiry hasbeen conducted by the Union Government into this; and
 - (e) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI NIHAR RANJAN LASKAR): (a) Yes.

(b) According to the information received from the State Government of Tamil Nadu, 153 cases of poliomyelitis with 17 deaths were reported in January. 1981, 212 cases with 17 deaths in February. 1981 and 196 cases with 28 deaths till 25th March, 1981.
