Casual Employees in Western Naval Command Bombay with over six or Seven Years Service

3102 SHRI BAPUSAHEB PARU-LEKAR: Will the Minister of DE-FENCE be pleased to state:

(a) whether it is a fact that about six to seven thousand employees are working as casual employees for over 6 or 7 years in F. O. C. in Chief, Western Naval Command Bombay, and if not the number of such casual employees and the period for which they are so working:

- (b) whether it is not a fact that the duties of casual employees are the same as that of other employees and the nature of job of all the casual employees is permanent;
- (c) whether it is not a fact that a compulsory break in service of casual employees is given to break their continuity in service and these workers are paid under old scales even after the declaration of new scales by the Third Pay Commission; and
- (d) whether Government propose to take any action in the matter to remove the discrimination and if not, the reasons and if so, the action proposed to be taken?

MINISTER OF STATE IN THE THE MINISTRY OF DEFENCE (SHRI SHIVRAJ V. PATIL): (a) The total number of casual empoyees in F.O.C. in Chief Western Naval Command Bombay, is 3466. The break up is as under:-

Casual emyployees with less than 1 year service-1084

Casual employees with 1 to 3 years service—1405

Casual employees with 3 to 7 years service-854

Casual employees above 7 years service-123

- (b) The duties of casual employees are the same as those of other regular employees in the same posts. However, the nature of job of casual employees is generally not permanent.
- (c) In accordance with instructions issued in November 1979, no break in service is to be given in respect of casual employees for posts which are considered essential are to be further continued. Break in service, however, is being given in the case of a small number of casual employees employed for spot jobs on as required basis. All causel employees are, however paid as per the new pay scales introduced on the re-

commendations of the Third Pay Commission.

(b) Government is actively considering he quesion of regularisation of the services of the casual employees who are required on a long term basis.

Site for Naval Academy
