(d) to (f). Executive instructions exist and are reiterated from time to time for the export contracts being entered into on C & F and imports contract on F.O.B. basis in order to ensure shipping arrangements in the hands of Indian exporters. By and large this policy is being implemented by the Public Sector Undertakings. However, due, to the bargaining strength of the importers and various other constraints, it is not always possible to strictly adhere to this policy.

Paimar Railway station
