During his visit to Patna in December, 1980, the Minister of Information and Broadcasting did mention Government's intention to set up TV stations at all State Capitals in a phased manner. Due to constraint on resources, it will not be possible to set up a new TV Centre at Patna or in North Bihar during the 6th Plan period (1980-85). However, there is a proposal to provide TV coverage to certain areas in Bihar through INSAT-I. Its implementation will depend upon the approval of the same and availability of resources.

- (c) whether it is also a fact that the matter was duly brought to the notice of the authorities, but no police case has been registered in this regard; and
- (d) if so, the reasons thereof?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI P. C. SETHI): (a) Yes, Sir.

(b) to (d), A high level Departmental Committee constituted by the Indian Oil Corporation has investigated the matter. It has been reported that while accounting the number of cylinders with one of their distributors, a discrepancy of 4000 cylinders was noticed by the Indian Oil Corporation. It has been brought out that the transport contractor for the distributor has been prima-facie involved in the case. The supplies to the concerned distributor has been suspended by Indian Oil Corporation immediately after the loss came to their notice. The award of transportation work to the contractor has also been suspended by the Indian Oil Corporation. # Agreement with Foreign Countries for Supply of Oil and Petroleum Products

133. SHRI RAMJI BHAI MAVANI: Will the Minister of PETROLEUM, CHEMICALS AND FERTILIZERS be pleased to state:

- (a) whether it is a fact that some agreements with the foreign countries on various occasions during March 1980 to 15th January, 1981 have been signed for the supply of various types of oils, crude oil, diesel, petroleum and petroleum products to India;
- (b) if so, the details of each one;

- (c) the benefit to be derived by India from each agreement.
- (d) how much percentage of the shortage of such products will be overcome as a result of these agreements;
- (e) whether more such agreements are expected to be signed with some other countries in the near future for which talks are going on;
- (f) if so, when such agreements are likely to be signed and what benefit will be derived by India therefrom; and
- (g) how much shortage they are likely to cover?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI P. C. SETHI): (a) Yes, Sir.

- (b) It would not be in the public interest to give details of source-wise imports.
- (c) The main advantage of such agreements is assured supplies for a specific period of time and at relatively stable prices.
- (d) Around 90 per cent of the crude imports and around 30 per cent of the product imports during 1980-81 are covered by such agreements.
  - (e) to (g). While organising imports of crude oil and petroleum products, efforts are always made to cover upto the extent possible the requirements by purchases by way of agreements concluded with the national oil companies of OPEC Countries. The balance requirements are met by purchases in the open market.
