THE MINISTER OF PETROLEUM. CHEMICALS AND FERTILIZERS (SHRI P. C. SETHI): (a) and (b). Government have decided in principle to set up two Petro-Chemical gas cracker complexes: one at Usar in Maharashtra and another at Kavas in Gujarat.

- (c) Details including cost estimates are yet to be finalised.
- (d) Normally, it takes 5-6 years to set up a Gas Cracker and its down stream units after the investment approval is given.

(c) Under the working programme of co-operation between India & USSR a coal complex in Jharia coalfields will be developed consisting of open-cast mine, washeries and captive thermal power station. Closure of Mysore Cement Factory at Ammasandara due to Shortage for Coal

200. SHRI TARIQ ANWAR: Will the Minister of ENERGY be pleased to state:

- (a) whether the Mysore cement factory at Ammasandara has been closed due to the shortage of coal;
- (b) whether the coal supply had been irregular during the last months and that the coal supply from the Western Coalfields for the said factory was diverted to Maharashtra Thermal Power Station:
- (c) whether Government will incur a loss of Rs. 3,00,000 daily due to the closure of the unit; and
- (d) what steps Government taking to restart the cement factory immediately and to maintain adequate supply of coal to the plant?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI VIKRAM MAHAJAN): (a) to (d). According to the information available Mysore Cement Factory at Ammasandara was closed due to shortage of coal on account of inadequate availability of wagons for movement for only one day in January '81. The plant has been operating at its rated capacity since the second fortnight of January '81. The coal supply to the southern cement units were not adequate in the month of December '80. However, the matter was taken up with the Ministry of Railways who have agreed to step up the movement of coal to all the cement plants including those in southern part of the country.
