THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P. VENKATASUBBAIAH): (a) and (b). The Combined Limited Departmental Competitive Examination for eligible Assistants and Grade 'C' Stenographers comprises of three distinct stages of work i.e. written examination in five subjects, a qualifying shorthand test (for those candidates who compete for Grade 'B' of the SSS etc.) and evaluation of record of service of qualified candidates. This takes longer time than in the case of one stage examinations. The Comhowever draws up a time mission bound programme of their examinations to be held in a particular year well in advance and every endeavour is made to adhere to the schedule of each examination.

(c) and (a). Appointments and promotions upto the grade of Section Officers in the CSS are decentralised and different cadres are responsible for the same. To avoid glaring disparities between various Ministries/Departments. Select Lists/Zones of promotion to long term temporary vacancies, however, are filled up by cadres conment of Personnel and Administrative Reforms and appointments are to be made from among the officers included in these lists zones to these vacancies. A few vacancies of short duration, however, are filled up by cadres concerned from among their own Assistants purely on an ad hoc basis pending availability of officers from Select List/long-term zones.

In pursuance of this Statement of Policy, raw materials have been identified and other details of the scheme are being worked out in consultation with . concerned agencies/institutions.

hilly areas power tillers in the range of 3 to 5-HP are considered suitable. The existing power tiller manufacturers have the capacity to manufacture them. As regards the tractors those below 25-HP are preferred for agricultural operations in hilly areas. Sufficient capacity exists for these types of tractors to meet the demand.

A list of manufacturers of small tractors (25 HP and below) and power tillers together with the price of each model is enclosed. These tractors and power tillers can be purchased from their dealers in various State.
