## Agitation in Ladakh

## 330. SHRI G. Y. KRISHNAN: SHRI €HINTAMANI JENA:

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) the reasons behind the agitation going on in Ladakh;
- (b) whether there has been any discrimination in diverting of funds towards Leh and Kargil on the basis of population only and not paying attention to the area or its backwardness; and
- (c) if so, whether the Central Government propose to advise the Jammu and Kashmir Government in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI YOGENDRA MAKWANA): (a) According to information furnished by the Jammu and Kashmir Government, the reasons behind the recent agitation in Leh were the following main demands made by the Action Committee, Leh:—

- (i) regional autonomy for Ladakh;
- (ii) establishment of Divisional Headquarters at Leh for both Leh and Kargil Districts:
- (iii) allotment of funds to Leh District on the basis of area and not of population;
- (iv) supply of adequate electricity; and
- (v) provision of adequate drinking water.
- (b) No, Sir. The distribution of funds between Leh and Kargil districts has been made by the State Government mainly on the basis of population with the objective of ameliorating the conditions of the people. Backwardness is

also a factor which is taken into account while making allocation but this factor would apply to the Ladakh region as a whole. Further, the Planning Commission does not fix criteria for the distribution of outlays between different districts of any State. It only allocates Central assistance according to the formula approved by the National Development Council.
