Disturbances in Leh

- (a) whether it is a fact that there have been large scale disturbances in Leh recently necessitating deployment of B.S.F.;
- (b) whether Government have obtained any report with regard to the reasons leading to the disturbances in Leh;
 - (c) if so, the details thereof; and
- (d) the reaction of Government thereto?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI YOGENDRA MAKWANA): Action Committee, Leh. organised demonstrations on the 30th November

and the 28th December, 1980. No B.S.F. troops were deployed on those occa-

- (b) and (c). According to information furnished by the Jammu and Kashmir Government, the demonstrations were a sequel to the following main demands of the Action Committee: -
 - (i) regional autonomy for Ladakh;
 - (ii) establishment of Divisional Headquarters at Leh for both Leh and Kargil Districts;
 - (iii) Allotment of funds to District on the basis of area and not of population;
 - (iv) supply of adequate electricity;
 - (v) provision of adequate drinking water.
- (d) It is primarily for the State Government to consider these demands. The State Government have initiated a dialogue with the representatives of the people of Ladakh region and the Central Government welcome
