MINISTER OF THE LAW. JUSTICE AND COMPANY AFFAIRS (SHRI SHIV SHANKAR): Yes, Sir.

(b) Government have taken with the Government of Pakistan the issue of Pakistan media campaign on the so-called arms build up in India. We have impressed upon them that such baseless and negative reporting on India in their Press hurts and does not help the process of normalisation between India and Pakistan. Other friendly Governments have been priefed on the correct position in matter. Prime Minister has publicly given expression to our commitment to building up friendship and good with Pakistan. This was relations reiterated most recently in PM's letter to President Zia.

## Murder of A.S. M. on duty at Sijua

425 SHRI A K ROY: Will Minister of RAILWAYS be pleased to refer to the reply given to starred Question No. 3712 on the 10th July, 1980 regarding murder of ASM on duty at Sijua and state:

- (c) the justification for not making over the case to C.B.I. when a year is going to pass but the murderer could not be traced out?

The case is iudice.
