## Fresh efforts made to settle Iran-Iraq dispute

454. SWAMI INDERVESH:

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether Government have made any fresh efforts/proposals/formula to bring peace and cease fire between Iraq-Iran; and
  - (b) if so, the details thereof?

THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI P. SHIV SHANKAR); (a) and (b). The Government of India are continuing their efforts towards bringing about a peaceful settlement of the Iraq-Iran conflict. For this purpose India has been in touch with the Government of Iraq and Iran as well as those of other Non-Aligned countries.

While expressing its profound regret at the continuation of the conflict, the recently concluded Non-Aligned Foreign Ministers' Conference has asked the Foreign Ministers of Cuba, India, Zambia and the Head of the Political Department of the PLO to exert all possible efforts in order to contribute to the implementation of the principles of the Movement of Non-Aligned countries as outlined in para 26 of the final Declaration of the Delhi Conference (Copy attached). The Indian Delegation was amongst those which played an active part in securing agreement in this respect.

## PARAGRAPH 26

While expressing its profound regret at the five months old Iraq-Iran war

and at the damages to lives and properties it has caused to the two nations, as well as the threat it poses to the Non-Aligned Movement, the Conference reiterated and emphasized the principles of the Movement of Non-Aligned Countries that no State should acquire or occupy territories by the use of force, and whatever territories have been acquired in this way should be returned, that no act of aggression should be committed against any state, that the territorial integrity and the sovereignity of all States should be respected, that no State should try to interfere or intervene in the internal affairs of other States, that all differences or claims which may exist between States should be settled by peaceful means with a view that peaceful relations should prevail among member States. The Conference asked the Foreign Ministers of Cuba. Zambia and the Head of the Political Department of the PLO to exert all possible efforts in order to contribute to the implementation of the aforementioned principles.
