being constructed next to the Oberoi and Lodhi Hotels and contractors had been ruthlessly hacking down massive Ashok and Neem trees lining Mathura, Lodhi and Zakir Hussain Roads and Lala Lajpat Rai path and some of the trees which have been standing for the last 40 years beautifying the Capital; and

(b) if so, whether Government has set up any expert Committee to examine and advice the Government regarding cutting down of the trees?

MINISTER OF STATE IN THE THE MINISTRY OF SHIPPING AND TRANSPORT-(SHRI BUTA SINGH): (a) and (b). About 164 trees and shrubs have been cut or require cutting in order to facilitate construction of flyovers at Lodhi Hotel and Oberoi Hotel inter-sections. The plans for construction of flyovers, widening of roads and improvement of intersections etc. are examined, in detail, by the Expert Co-ordination Committee under the Chairmanship of Engineer-Member, Delhi Development Authority and are adjusted/modified to minimise the cutting of trees, if possible. Efforts were also made to save these 164 trees and shrubs but in view of limited space available, these could not be saved.

Taicher and Rourkela

4267. SHRI K. P. SINGH DEO: Will the Minister of SHIPPING AND TRANSPORT be pleased to state:

- (a) whether keeping in view the industrial activities that are coming up in Talcher and the existing ones in Rourkela, Government have been urged by the Orissa Government to strengthen the National Highway passing through it and keep them open for the whole year;
- (b) if so, whether Government have considered this issue; and
- (c) the reaction of Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI BUTA SINGH): (a) to (c). No specific proposal for improvement of National Highway No. 23 as a whole has been received from the Government of Orissa with respect to its industrial importance: the Government of India recognise the importance of this route and propose to upgrade it in stages further by taking up different works like provision of missing bridges, construction of missing road link, widening and strengthening of carriageway etc. during the 1980-85 Plan subject to availability of funds and inter-se priority of the various National Highway works in the country as a whole.
