Underground Nagas Sanctuary in Burma

4270. SHRI S. B. SIDNAL:

SHRI SONTOSH MOHAN DEV:

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether it is a fact that the underground Nagas have made their sanctuary in across the International borders inside the Burmese territory;
- (b) if so, whether Government propose to take up the matter with the Government of Burma; and

(c) the details thereof?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO): (a) The Government are aware that the Indian Naga hostiles have some presence in Burma which gives them a continued capacity to create trouble inside our country.

(b) and (c). The Government have, from time to time, communicated all available information about hostile Nagas and requested the Government of Burma to take necessary action against such elements in keeping with their policy of not permitting their soil to be used against a friendly neighbour. The Burmese authorities have been exerting increasing pressure on these elements in order to force them to leave their territory.

Dacoities in Trains in U.P. and Bihar

4271. SHRI ERA MOHAN: Will the Minister of RAILWAYS be pleased to state:

- (a) the number of trains looted by dacoits in U.P. and Bihar from January, 1980 till date;
- (b) the nature and the value of goods looted;
- (c) the number of deaths, if any in the course of dacoity;
- (d) the result of investigation in each case as to the number of dacoit arrested and the property recovered;
- (e) whether such occurrence has taken place elsewhere in other States; and
- (f) if so, the protective measures taken by the Indian Railways to prevent such dacoity menace?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN); (a) 24 and 41 cases of

dacoity were reported in running trains in Uttar Fradesh and Bihar respectively from January, 1980 to February, 1981.

- (b) Cash, clothes, ornaments, watches and other personal belongings worth Rs. 2,89,139.35 and Rs. 3,23,644 were looted from running trains by dacoits in Uttar Pradesh and Bihar respectively.
- (c) In the above incidents, 3 persons were killed in Uttar Pradesh.
- (d) 59 dacoits in Uttar Pradesh and 110 dacoits in Bihar were arrested and property worth Rs. 24,439 and Rs. 36,450 respectively were recovered in these cases

(e) Yes.

(f) The Railway, are deeply concerned over the occurrences of crimes being committed on the passengers. But the Railway has no jurisdiction over the matters of law and order which is, under Constitution, a State subject. However, the Railways in co-ordination with the State Governments are making all out efforts to protect passengers. Besides, deployment of 2,000 RPF personnel in assisting Government Railway Police in escorting trains, beat patrolling at stations/platforms|waiting checking of night trains by officers, posting of pickets at vulnerable stations are being done. Vestibuled doors of coaches are kept closed between 2200 hrs. and 0600 hrs. TTEs Attendants Conductors have instructions to remain vigilant and prevent entry of unauthorised persons into the coaches particularly in reserved compartments.

Increase in Crime_s in Eastern Railways

4272 SHRI JANARDHANA POO-JARY: Will the Minister of RAU-WAYS be pleased to state:

- (a) whether it is a fact that crimes ranging from wagon breaking to pil-ferage of booked consignments are on the increase on the Eastern Railway;
- (b) if so, the number of wagon breaking incidents during 1979 and 1980 which took place and loss to Railways due to these incidents during this period;
- (c) the reasons for increase in incidents; and
- (d) what steps have been taken and proposed to be taken by Government to tackle the situation?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) and (b). The number of cases of wagon breaking, pilferages etc. of booked consignments have no doubt increased in 1980 on the Eastern Railway, when compared with 1979. But in consideration of the value of the property stolen, the trend is decreasing as may be seen from the undermentioned table:—
