THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIA. (SHRI **AFFAIRS** MENTARY The MALLIKARJUN): (a) to (d) Railways pay compensation to victims of train accident under the provision of Indian Railways 1890 and Railway accidents pensation) Rules 1950 as amended from time to time. In this case all the six cases are pending with Ex-officio Claims Commissioner (Distt. Magistrate) Kangra at Dharamsala. The compensation will be paid on the basis of verdict of the court when received. However, the families of the six deceased persons have been paid interim compensation. The names and addresses of the persons killed in accident are given in the attached statement.
