THE DEPUTY MINISTER IN THE MINISTER OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) Yes.

(b) to (d). The feasibility of extending the shuttle train between Delhi and Meerut City to and from Meerut Cantonment has been examined but not found operationally feasible due to terminal constraints at Meerut Contonment and saturation of line capacity on Meerut City-Meerut Cantonment section.

Container Consortium of Indian Chipping Lines

4335. SHRI JAGDISH TYTLER: will the Minister of Shipping AND TRANSPORT be pleased to state:

- (a) whether it is a fact that three Indian lines, viz. the Shipping Corporation of India, the Scindia Steam Navigation Company and Indian Steamship have decided to function as a Container Consortium; and
- (b) what Government propose to do in the matter?

THE MINISTER OF SHIPPING AND TRANSPORT (SHRI VEEREN-DRA PATIL): (a) Yes, Sir. The proposed consortium is expected to commence its operations from 1-4-1981 with one sailing from Calcutta in the first week of April, 1981 and thereafter with a fortnightly frequency. The container sailings will call directly at Calcutta, Madras, Cochin Bombay and touch Felixatowe in the UK and Rotterdam and Hamburg on the Continent. The service will accept cargo to and from the main ports in the UK and the Continent. This container service will also be backed by conventional vessels to cater to the residual break-bulk cargo. The breakbulk service will operate to and from ports where container vessels do not call.

(b) The proposed consortium is a commercial activity of the shipping lines aimed at providing better service.
