Back-Log among Scheduled Caste and Tribe Employees of Central Warehousing Corporation

4585. SHRI RAMESHWAR NEE-KHRA: Will the Minister of AGRI-CULTURE be pleased to state:

(a) whether it is a fact that there is no representation from Scheduled Caste Scheduled Tribe Community in clause I and II cadre in the Central Warehousing Corporation;

(b) if so, the reasons therefor and when the back-log will be completed; and

(c) whether it is also a fact that there is no Liaison officer/Liasion cell at Head Office level Regional office level and if so, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND RURAL RECONSTRUCTION (SHRI R. v. SWAMINATHAN): (a) and (b) No, Sir. As on 31-12-1980 12 Class I and 34 Class II Officers be longing to Scheduled Castes and 2 each in Class I and II belonging to Scheduled Tribes were in the service of the Central Warehousing Corporation. However, there has been some back-log in filling up the reserved vacancies as the Supreme Court has stayed the implementation of the 40 point roster in the Central Warehousing Corporation on a Writ Petition filed by the Central Warehousing Corporation Employee's Union (North Zone & Head Office) in December, 1979.

(c) No, Sir. The Personnel Manager of the Corporation is acting as Liaison Officer. There is also an Implementation Cell headed by an officer belonging to Scheduled Castes in the Personnal Division of the Corporation to ensure complaince with the Government instructions regarding representation of Scheduled Caste and Scheduled Tribe Candidates in the various cadres of the Corporation.

Non-observance of Government of India Reservation Order in Central Warehousing Corporation
