(क) रोहिणी स्कीम दिल्ली विकास प्राधिकरण ने बनाई है। दिल्ली विकास प्राधिकरण ने सूचित किया है कि स्कीम में दी गई श्रेणीवार प्लटों की संख्या निम्न प्रकार है:—

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KARTIK ORAON): (a) No, Sir.

Saline Land

4620. SHRI BAGUN SUMBRUI: Will the Minister of AGRICULTURE be pleased to state:

(a) whether it is a fact that more land is going saline in the country;

(b) whether any study has been undertaken in regard to the land already gone saline during the last ten years and what are its details; and

(c) whether it is proposed to develop a package technology for the proper management of saline land?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND RURAL RECONSTRUCTION (SHRI R. V. SWAMINATHAN): (a) and (b). No definite study/survey has been done so far to determine the extent of land that has gone saline during the last ten years. However, considerable areas, which have come under irrigation in the last few decades, are reported to be affected by waterlogging and salinization.

(c) Yes, Sir. The Indian Council of Agricultural Research is developing suitable technology for reclamation of saline soils.
