Committee to review Allotment Policy of Land on Lease to Displaced persons

The Govt, set up a Committee called "the Committee on administration of land in Delhi" in 1977 under the Chairmanship of the former Secretary, Ministry of Works and Housing (Shri J. B. D'souza) to examine the system of land tenure in Delhi and administration of leases by different authorities.

- (c) Yes, Sir.
- (d) and (e). The recommendations are under consideration of the Govt.

Fixation of Minimum price of Cocoa

However, it is estimated that the quantity produced during 1980-81 is about 3600 tonnes of dry cocoa beans. Estimated area under cocoa cultivation during 1979-80 was about 19,000 hectare.

(b) A plan of action has been evolved by the Central Board the Prevention and Control of Water Pollution in consultation with State Board and Gujarat Industrial Development Corporation to control the pollution of the river. The Gujarat Industrial Development Corporation is taking steps to implement the plan of action.

THE MINISTER OF PARLIAMEN --TARY AFFAIRS AND WORKS AND HOUSING (SHRI BHISHMA NARAIN SINGH): (a) so far the Government of India have approved 2210 schemes for 2601 villages in Maharashtra at a
