(c) Selection for this post is held out of highly skilled Grade I & I Artisans and Mistries. If sufficient number is not available out of these, other skilled staff in Carriage & Wagon Department who fulfil the following conditions are also considered:---

(i) 5 years of service in the skilled grade with 8th standard qualifications.

(ii) 3 years of service in skilled grade with Matriculation.

### Golden Rock Railway Workshop

8414. SHRI S. SINGARVADIVEL: Will the Minister of RAILWAYS be pleased to state:

(a) whether there is any proposal to make use of the Railway Workshop of the Golden Rock, Southern Railway for repairing and manufacturing Railway wagons;

(b) if so, whether Government propose to take up the matter immeditely; and

(c) if not, the reasons therefor?

DEPUTY MINISTER IN THE OF RAILWAYS THE MINISTRY AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) Golden Rock workshop of Southern Railway is railway manufacturing already wagons at the rate of 960 per annum. There is no proposal to expand this capacity or set up capacity for repair to wagons.

(b) No.

(c) Golden Rock is one of the most diversified workshops on the Indian Railways. Its range of activity include overhaul of broad gauge diesel, meter gauge diesel and meter gauge steam locomotives, overhaul of broad gauge and meter gauge coaches. overhaul of cranes, steam cranes, both broad & meter gauge, corresion rapair of steelbodied coaches, wagon manufacture, diesel engine re-building, chromeplating of cylinder liners re-wiring of coaches etc. It is no tenvisaged to diversify the workshop further by adding the activity of wagon repairs also. In any case, capacity to repair wagons in the southern region has already been catered for and there is no proposal to generate this capacity at Golden Rock.
