(c) and (d) Construction of road over/under-bridges in replacement of existing level crossings is undertaken jointly and on cost-sharing basis with the State Government/Road Authority, who are required to sponsor firm proposals therefor and give an undertaking to bear about 50 per cent of the cost as per extent rules. No firm proposal for construction of a road over-bridge in replacement of any of the level crossings near Alwar has so far been sponsored by the State Government/Road Authority.
