The All India Station Masters' Association is stated to have generally represented the case of employees alleged to have been victimised by the railway administration and in the course of this they also mentioned the case of Shri B. C. Pal.

Shri B. C. Pal ASM/Sahebganj was arrested in the context of his activities which attracted the provisions of the Indian Penal Code and it had nothing to do with his activities as an office bearer of the Association.

Upgradation of Train Examiners

More Training Ships
