Committee on Reorganisation of Railway Zones

9378. PROF. NARAIN CHAND PARASHAR: Will the Minister of RAILWAYS be pleased to state:

- (a) whether Covernment have decided to set-up a High Powered Committee for the reorganisation of the administrative (Zonal and Divisional) set-up of the Railways in the country; and
- (b) if so, the terms of reference and composition of the Committee as also the period by which it would be required to submit its report?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND DEPARMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN):

(a) Yes.

(b) The composition of the Committee and terms of reference are under consideration.

Writing of Confidential Reports

9379. SHRI SANAT KUMAR MAN-DAL: Will the Minister of RAIL-WAYS be pleased to state:

- (a) whether there exists any orders issued by his Ministry or the Northern Railway Administration to the effect that Senior Railway Officers retiring from service on 31st March of a year should write the Confidential Reports of their subordinate officers and staff for the year ending 31st March of that year and hand them over to their successors while relinquishing charge;
- (b) if so, what are the orders and if not the reasons therefor;
- (c) whether it is open to a retiring officer to take such blank forms of Confidential Reports at his residence, write them Icisurely in back-dates and then submit them to the Reviewing Officer; and

(d) if so, whether this practice is permitted under any rule or order, if so, under which rule and if not, what steps are taken to prevent such mal-practices?

THE DEPUTY MINISTER IN THE MINISTER OF RAILWAYS AND DE-PARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) and (b): In terms of Rule 1612 of the Indian Railway Establishment Code Volume-I, when a reporting officer vacates his post on account transfer, leave &c. and is not likely to return to the post during the year, or if he vacates his post on account of retirement, he should, before making over charge of his post to his successor, record his opinion on all gazetted railway servants who have served under him for a period of three months or more.

Instructions were, however, issued that the reporting, reviewing and accepting authorities shall not be competent to record the remarks in the Confidential Report on a Class-I Officer, after he retires from service.

In the case of non-gazetted staff instructions exist that the retiring officer may be allowed to give the report on his subordinates within a month of his retirement.

(c) and (d): There is no objection to the reports being written at the reporting officers residence; back-dating is, however, not in order. No specific orders have, however, been issued in this connection.

Housing Accommodation for Ambassadors and Diplomats

- 9380. DR. VASANT KUMAR PANDIT: Will the Minister of EXTERNAL AFFAIRS be pleased to state:
- (a) whether some Ambassadors and Diplomats of newly independent or small countries have requested the Government to help them in finding Housing accommodation for their stay in New Delhi;
- (b) if so, the details thereof and the help rendered by the Indian Government to them;

- (c) whether Government have a proposal to find plots or flats for foreign Ambassadors and/or Diplomats on their tenure in New Delhi or India:
 - (d) if so, the details thereof; and
- (e) if not, whether Government propose to requisition bungalows or flats for this public purpose as an Act of hospitality?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMIIA RAO): (a) Yes, Sir.

- (b) Several of the newly opened diplomatic missions like those of Cyprus, Kampuchea and Tunisia have either formally or informally sought our assistance in this context. We have given them appropriate advice and contacts which they have to pursue themselves.
 - (c) No, Sir.
 - (d) Does not arise.
- (e) Government do not consider this feasible.
