- (c) After introducing reservation in promotion w.e.f. 1-3-1978 the Bank has conducted two All India Service Tests on 30-4-1978 and on 28-9-1980.
- (d) and (e). The Bank has reported that in All India Service Test held in 1980 sufficient number of SC/ST candidates had appeared and that the percentage of successful SC/ST candidates was much better than that in the earlier test. This was mainly because of the exclusive pre-examination coaching training imparted to the SC/ST empoyees. The Bank, therefore, does not consider it necessary to hold any exclusive test for the SC/ST employees in 1981.

Cancellation by AI of Direct Flight from Calcutta to New York
