Will the Minister of RAILWAYS be pleased to state:

 (a) whether his Ministry has received representations for starting rail link between Kadur-Chikmagallur-Hassan;

(b) if so, details thereof; and

(c) action contemplated by Government in the matter?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PAR-LIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) to (c). Several representations for construction of a railway line from Kadur-Chikmagalur-Mudigere/Belur - Saklespur-Hassan have been received. Saklespur and Hassan are already linked with MG line. There is no proposal to take up construction of the balance suggested line at present due to paucity of resources.

## Effect of multistoryed buildings in N.D.M.C. area on Jantar Mantar

4698. SHRI BHIKU RAM JAIN: Will the Minister of EDUCATION AND SOCIAL WELFARE be pleased to state:

(a) whether the high-rising multistoreyed city centre of the New Delhi Municipal Committee is casting a shadow on the remarkable historical building Jantar-Mantar making astronimical circulation impossible; and

(b) whether the Archaeological Survey of India had requested the Prime Minister to intervene to prevent the city centre from being constructed any further; and (c) if so what measures are proposed to be taken to save this rare and important structure from being overshadowed?

THE MINISTER OF STATE OF THE MINISTRIES OF EDUCATION AND SOCIAL WELFARE (SHRIMATI SHEILA KAUL): (a) The multistoreyed city centre of the NDMC casts its shadow on the Jantar Mantar monuments after 5 p.m. in the months of June and July.

(b) No, Sir.

(c) The building casts shadow on the protected monument only after 5 p.m. during the months of June and July. The Archaeological Survey of India has requested the Urban Arts Commission not to permit high rise buildings on the north-east, east and south-east sites of the monuments which may cast shadows on it.
