that an Institution for higher education shall be deemed to be a University. The Institution of Engineers is primarily a professional body, and the Membership examination conducted by it is recognised for purpose of recruitment to superior posts under the Central Government.

Allahabad Division Train Examiners

4778. SHRI SURAJ BHAN: Will the Minister of RAILWAYS be pleased to state:

- (a) whether it is a fact that the seniority of about 11 Train Examiners of Allahabad division of Northern Railway was wrongly fixed above so many other trains examiners;
- (b) whether in an informal meeting with union officials decision to revise the seniority of these 11 persons was taken to ensure that these persons are not given undue benefit;
- (c) if so, whether the seniority of these persons has since been revised;
 - (d) if not, the reason thereof;
- (e) by what time the same is likely to be implemented;
- (f) whether there is any hitch to implement the same; and
- (g) what remedial measures are being taken by the administration to avoid the same?

Seniority of Train Examiners of Lucknow

4779, SHRI SURAJ BHAN; Will the Minister of RAILWAYS be pleased to state:

- (a) whether it is a fact that the seniority of persons recruited directly among themselves is reckoned on the basis of the merit they obtain in the training period they undergo before being posted on working posts as train examiners;
- (b) if so, whether it is a fact that some of the train examiners posted on Lucknow division in the year 1958 after training have not been assigned their due seniority vis-a-vis their batch-mates in other divisions, though they were having better merit positions;
 - (c) if so the reasons thereof; and
- (d) what remedial measures are proposed to be taken by the administration of Northern Railway to correct the seniority and by what time?
