Tourists to Delhi

192. Shri D. C. Sharma: Will the Minister of Transport and Communications be pleased to state the number of foreign tourists who visited Delhi during 1956?

The Minister of State in the Ministry of Transport and Communications (Shri Raj Bahadur): There were 15.212 visitors who arrived in Delhi by air directly from foreign countries during 1956. Of these about 2th are presumed to be tourists. However, a much larger number of foreign tourists did visit Delhi having first entered India through one or the other of the various ports of entry. But no definite figures for such tourists are available.

- 3. Chenganacherry

4. Chikmagullur.

One of the above Out-agencies, namely, Chikmagullur was reopened on 15-3-1957.

Passenger Amenities at Jind Junction
