Development of Infrastructure facilities for small fishing harbours

2031. SHRI A. A. RAHIM: Will the Mintster of AGRICULTURE be pleased to state:

- (a) is there any proposal to develop infrastructure facilities for the small fishing harbours; and
- (b) Kerala being an important coas_ tal state with highest sea food exports, what steps are being taken to develop fishing ports so that fishing boats can be taken to sea during monsoon periods?

THE DEPUTY MINISTER IN THE MINISTRIES OF AGRICULTURE AND RURAL RECONSTRUCTION (KU-MARI KAMLA KUMARI): (a) Yes, Sir. Under the existing scheme 50 per cent assistance from Government of India is available for development of fishing harbours/landing and berthing facilities. Such projects normally include infrastructure facilities.

(b) Fishig ports are provided under three broad categories basically to provide shelter to the fishing boats. They also enable hygienic handling of fish, for supply of essential requisites like fuel, water and ice etc.

The fishing ports already sanctioned in Kerala by the Government of India are as follows:

I-Major Port

1. Cochin

II-Minor Ports

- 1. Vizhinjam (Stage I).
- 2. Cannanore

III Landing and berthing facilities for small crafts (basic facilities)

- 1. Ponnani
- 2. Baliapatnam.

Recently (in July 1981) two more projects, namely, Neeleshawaram and Munnakkadavu have also been approved.
