# Profits of Limited Companies

388. Shri V. P. Nayar: Will the Mininster of Finance be pleased to state:

- (a) the total profits carned by limited companies, (public and private to be shown seperately) during the year 1955-56; and
- (b) their total assets and liabilities for the above year?

The Minister of Finance (Shri T. T. Krishnamachari): (a) and (b). information is not readily available. Its collection will involve the examination of the annual accounts of nearly 30,000 companies, two thirds of the number being private companies which will be filing balance sheets for the first time with the Registrars of Companies only hereafter, and entail time and labour which would not be worthwhile.
